Please submit ***this form and the guidelines*** to the Mesa Community College Honors Office by ***the first week of August***. Registration for Fall starts the first week of March.

Prop 300: State law now requires that a person who is not a citizen or legal resident of the United States or who is without lawful immigration status is not entitled to classification as an in-state student pursuant to A.R.S. Presidents' Scholarship Agreement / Guidelines

Directions: Please read the following information carefully, sign at the bottom of the page and return to the Honors Program.

The President's Scholarship is a tuition waiver that covers in-county tuition, and the registration fee, up to fifteen credit hours for *four consecutive semesters*, excluding Summer sessions. It **DOES NOT COVER:** additional class fees, *books*, private instruction/ music lessons, **summer classes**, or remedial classes (**classes below the 100 level**).

Acceptance:

Students applying for a MCC Presidents' Scholarship must meet all of the following requirements to receive the scholarship.

- Submit the Presidents' Scholarship application to the Honors Office **in the Social and Cultural Sciences Building (#14) at Southern & Dobson** OR to the Enrollment Services Office at the Red Mountain Campus.
- Graduate from a **Maricopa County high school**. (* A **FINAL** transcript ***must be submitted AFTER*** graduation.)
- Verify rank in the top 15% of their NCA-accredited Maricopa County high school class in the sixth, seventh or eighth semester **OR** Achieve the following scores on the admissions placement tests:

Upon graduation, **submit one official high school transcript indicating Graduation Date, Rank in Class, Final GPA, and School Seal** to the Honors Office. Enroll at Mesa Community College within one academic year following high school graduation **without having attended** another college or university before enrolling in a Maricopa Community College.

Requirements, Retention and Renewal:

For the presidents' scholarship to be automatically renewed each semester (up to four consecutive semesters), the students **must** meet all of the following requirements:

- Must **complete** twelve or more credit hours of **100 level** or above *per semester* ~ Consortium agreements are available with any of the other Maricopa Community Colleges (contact to Honors Program office for more information).
- **Must be enrolled in one of the "Honors Only" classes offered each Fall and Spring semester.**
- Must complete and receive a "C" or higher in your Honors class(es).
- No Pass/Fail classes will be counted towards required hours (except students enrolled in a program that requires Pass/Fail classes) * **PSY 102 will no longer be accepted as a credit toward your twelve credits starting Fall 2009.**
- Must have a minimum **cumulative** GPA of 3.25, or higher, **at the end of each semester.**
- Must complete twelve credit hours each semester, with a total of twenty-four Credit Hours by the end of each academic year.

Graduating from the Honors Program:

To graduate **from** the Honors Program, students must meet the following requirements:

- Complete a minimum of fifteen (15) credits of Honors credits (pass/fail credits excluded) and one (1) credit of service learning.
- Have a cumulative GPA of 3.5 or higher.
- Petition for Graduation in the Advisement / Records Office (see appropriate class schedule for deadlines).

Important Notes:

At the end of the drop/add period the student's enrollment is reviewed. **If the student is enrolled in less than 12 credit hours or not in an honors only class, the scholarship funds will not be awarded. Tuition and fees will then be the students' responsibility.** Honors students' should not withdraw from courses without first consulting with the Honors Program. **We do offer a deferment that will defer the scholarship for up to twenty-four months; contact the honors office for more information.**
