For Nonunion Employees

At Boeing, we make a significant investment in attracting, developing and rewarding the best people. After all, people are our greatest strength. Our Total Rewards include a range of benefits designed to meet the needs of our employees as they grow their careers, and the needs of their families and communities. This summary includes information about benefits generally available to nonunion salaried employees at most Boeing locations.



Compensation

Boeing invests over \$13 billion in pay every year to recognize and reward performance.

Base Pay

Your Base Pay is influenced by a number of factors — the content and level of work you perform in your job on a daily basis, the value of the job in the external marketplace, the business environment, and the value of your contribution to the company's success over time.

Incentive Pay

Along with Base Pay, individual incentive award opportunities are one of the cornerstones of our pay-for-performance culture. Based on One Boeing metrics, the better the company does as a whole, the better your incentive award opportunity. For most salaried nonunion employees, personal performance is also a major factor in determining actual award payout.

Recognition

Recognition can take the form of Pride@Boeing points, which are awarded for performance beyond normal job requirements and can be exchanged for gifts or gift cards. And there is the Cash Award Program, which recognizes individual or team accomplishments that are the result of truly extraordinary performance.



Financial Security

Be prepared for life during and after your career through market-leading retirement savings plans, financial well-being programs, tax-advantaged accounts and insurance options currently available.

Voluntary Investment Plan (VIP)

The VIP — ranked by Bloomberg as the #2 401(k) plan for its generous company contributions and other features — offers the flexibility to choose how to save, how much to save and how to invest savings over time. The VIP provides:

- Generous company contributions made each payroll period for most employees.
- Diverse investment fund options, including Lifecycle Funds.
- Roth saving and conversion options.
- Immediate vesting.
- Supplemental Savings Plan for after reaching IRS limits in the VIP.



Well Being

- Financial Engines, an independent investment advisory company, offers complimentary Retirement Checkups (which include broad financial planning), online tools and fee-based services.
- On-site and online seminars.
- Educational videos available on demand.

Tax-advantaged Accounts

- Health Savings Accounts (only available with the Advantage+ health care plan) roll over each year and are portable.
- Flexible Spending Accounts (FSAs) pay for qualified expenses not covered by the health care plans. Both Health Care FSA and Dependent Care FSA are offered.

Life and Disability Insurances

- Short-term Disability.
- Long-term Disability.
- Basic & Supplemental Life Insurance.
- Basic & Supplemental Accidental Death & Dismemberment (AD&D) Insurance.
- Business Travel Accident Insurance.

Coming in 2020: A new "pay for education" benefit for surviving dependent children in the event of an eligible employee's death.

Health Care Benefits and Tools

Boeing provides comprehensive health care benefits with a full range of services — from preventive care to health improvement programs — to meet the various needs of you and your family. **Note:** Coverage begins on the first day of the following month that employees are hired.

- On-site fitness centers are located in certain areas.
- On-site health screenings are available limited times of the year in many locations.
- Discounts to weight management programs and community fitness centers are also available.



Life

Reach personal goals, manage life events and develop fulfilling relationships.

Time Off

- Paid time away from work generally includes Vacation, Sick Leave and up to 12 holidays per calendar year.
- Boeing offers leaves of absence for many life events, including family and medical leave, pregnancy and adoption (both paid if using earned Sick Leave), paid parental leave for mothers and fathers (12 weeks) and military duty.
- Eligible employees receive time off with pay for jury duty and temporary military service.

Flexible Work Options

A variety of flexible work options are available in accordance with organizational guidelines and business needs. Flexible work options include Telecommuting, Alternate Work Schedules, Part-time Work Schedules and Flexible Redistribution of Hours. Managers are responsible for defining how these work arrangements enhance their team's effectiveness, collaboration and engagement.

Adoption Assistance

The company reimburses up to \$10,000 of eligible adoption expenses related to the adoption of a child under the age of 18 (for up to two adoptions).

Boeing Discount Program

Save money on a wide variety of goods and services — including automotive, dining and entertainment, electronics, home goods, services, travel and wireless phones.

Enterprise Commuter Services

Use benefits such as pretax payroll deductions and ride-matching tools for alternate commuting methods (varies by location).



Well Being

- Well Being Co-Pilot is a digital destination where users earn points and get rewarded when they achieve goals.
- The Employee Assistance Program connects Boeing employees and their families with counseling professionals for confidential help — at no cost — with personal, family, or workplace issues.
- Work/Life Solutions provides free, confidential referrals for a variety of services, such as elder care or child care services, plus resources for stress management, parenting skills, consumer issues and caregiver support.
- Total Brain is an online stress management program.
- Health assessments help people identify and prioritize risk factors.

Coming in 2019:

 Back-up elder care and child care services to support families through all caregiving stages.

Coming in 2020:

- Vacation and Sick Leave combine into a single Paid Time Off account offering eligible employees more flexibility.
- Choose from several new voluntary benefit programs (including critical illness insurance, legal services and pet insurance), paid on an after-tax basis through paycheck deductions.
