

# MESA COMMUNITY COLLEGE DOMICILE AFFIDAVIT

## To Be Completed By Parent or Spouse of Dependent Student

Residency for tuition purposes is determined in accordance with state law (A.R.S. §15-1801 et. sec.) and regulations of the Maricopa Community Colleges Governing Board. All of the Maricopa Community Colleges are subject to the above statutes and regulations. Students who have questions about their residency should contact the Office of Admissions and Records for clarification.

The responsibility of registration under the proper residency classification is placed upon the student. Any student who is found to be classified improperly shall be required to pay full out-of-state tuition. In determining a student's classification, the college may consider all evidence, written or oral, presented by the student and any other information received from any source which is relevant to determining classification. The college may request written sworn statements or sworn testimony of the student. Furnishing false information to any official, college employee or office is a violation of the Student Code of Conduct (AR 2.5.2) and subject to disciplinary sanctions.

If you are a dependent of parents/spouse who reside in Arizona, the following may apply to you:

A student whose parent(s) claims him/her as a dependent for federal and/or state income tax purposes and whose parent(s) moved to the State of Arizona on or before the first day of the semester may be eligible for classification as in-state student for tuition purposes. Proof of tax dependence and domicile of parent(s) in Arizona required.

A student who has filed joint income tax return with his/her spouse and his/her spouse is an Arizona resident. Proof of state and federal income tax and domicile of spouse in Arizona required.

**NOTE:** This regulation applies only to a dependent son or daughter and spouse of Arizona resident.

If these conditions **do not** apply to you, please refer to the Residency Guidelines and complete the Domicile Affidavit, Independent Student form.

Parents/spouse of students who meet these conditions may complete lower portion and reverse side of this form and submit along with:

1. Copy of state and federal income tax return (for the most recent tax year)
2. Proof of parent/spouse domicile in Arizona (at least two). Any of the following may be used in determining parents/spouse domicile:
  - Proof of employment in Arizona
  - Arizona driver's license
  - Proof of purchase or rental of home or apartment occupied by parent(s)/ spouse
  - Arizona voter registration
